**EMERGENCY CERTIFICATION OF
INABILITY TO OBTAIN AN IN-PERSON QUORUM**


WHEREAS, the Louisiana State Board of Social Work Examiners board meetings require having an in-person quorum to conduct board business;

WHEREAS, due to measures necessary to protect the health and safety of the public, the Louisiana State Board of Social Work Examiners is not be able to attain an in-person quorum for the board meeting scheduled for Friday, June 12, 2020 at 8:30 a.m.

WHEREAS, pursuant to The State of Louisiana Executive Department Proclamation 30 JBE 2020, Section 4 as extended by subsequent executive proclamations including 75 JBE 2020 requiring all state boards and commissions and local political subdivisions of the state to:

Provide for attendance at essential governmental meetings via teleconference or video conference and such attendance shall be allowed during the pendency of this emergency. All efforts shall be made to provide for observation and input by members of the public.

NOW THEREFORE I, Emily DeAngelo, Administrator, on this 10th day of June, 2020 hereby certify, pursuant to 30 JBE 2020 as extended by subsequent executive proclamations including 75 JBE 2020, that the Louisiana State Board of Social Work Examiners will otherwise be unable to operate due to quorum requirements and therefore, will conduct the June 12, 2020 Board Meeting via teleconference to meet quorum requirements.
