## EMERGENCY CERTIFICATION OF POSSIBLE INABILITY TO OBTAIN AN IN-PERSON QUORUM

WHEREAS, the Louisiana State Board of Social Work Examiners' board meetings are required by statutory law to be conducted in-person with a quorum consisting of at least four board members present to take action on agenda items;

WHEREAS, La. R.S. 42:17.1 authorizes public bodies to conduct a meeting and its members to attend and participate in a meeting via electronic means when the governor has declared a state of emergency and the nature of the emergency would cause a meeting of the public body conducted pursuant to the open meeting law to be detrimental to the health, safety, or welfare of the public;

WHEREAS, by Proclamation Number JBE 2020-25 and extensions thereof, Governor John Bel Edwards pursuant to the Louisiana Health Emergency Powers Act, La. R.S. 29:760, et seq. declared a statewide public health emergency to exist as a result of the imminent threat posed to the Louisiana citizens by COVID-19, which has created emergency conditions that threaten the lives and health of the citizens of the State;

WHEREAS, in the event the Louisiana State Board of Social Work Examiners ("Board") is unable to attain an inperson quorum for its meeting scheduled for 8:30 a.m. CST on Friday, August 21, 2020 without a detrimental impact to the health, safety, or welfare of the public, the Board intends to conduct the meeting via electronic means; **NOW THEREFORE I**, John Shalett, Chairperson for the Louisiana State Board of Social Work Examiners, hereby certify, pursuant to La. R.S. 44:17.1, that in the event of an inability obtain an in-person quorum at the Office of the Louisiana State Board of Social Work Examiners, the August 21, 2020 Board Meeting will be conducted and members will participate via electronic means to consider items on the agenda meeting the following criteria:

- (a) Matters directly related to the public body's response to the disaster or emergency and are critical to the health, safety, or welfare of the public;
- (b) Matters that if delayed will cause curtailment of vital public services or severe economic dislocation and hardship;
- (c) Matters critical to continuation of the business of the Board that are not able to be postponed to a meeting to be held in accordance with other provisions of the Open Meetings Law due to a legal requirement or other deadline that cannot be postponed or delayed by the Board.
- (d) This notice and the agenda for the meeting will be posted on the Board's website and emailed to any member of the public or the news media who requested notice of Board meetings including information on how members of the public may participate in the meeting and submit comments regarding agenda items prior to and during the meeting.
