CONSENT AGREEMENT AND ORDER

WHEREAS, Elizabeth Oliveira is a credentialed social worker subject to the jurisdiction and rules and regulations of the Louisiana State Board of Social Work Examiners (the Board); and

WHEREAS, pursuant to a complaint and an administrative investigation, the social worker, Elizabeth Oliveira, has indicated her desire to resolve this matter through a Consent Agreement and Order as provided for in Rule No. 907 of the Board's Rules, Standards and Procedures and La. R.S. 49:955(D) of the Louisiana Administrative Procedure Act; and

WHEREAS, the social worker, Elizabeth Oliveira, has admitted the following:

1. Respondent, Elizabeth Oliveira , (Ms. Oliveira) is and at all times pertinent to the facts and matters alleged herein, a Graduate Social Worker (GSW), credentialed by the Board to engage in the practice of social work in the State of Louisiana pursuant to the Social Work Practice Act, La. R.S. 37:2701 et seq., as evidenced by License No. 6362.

2. At all times pertinent hereto, Ms. Oliveira was actively engaged in the practice of social work.

3. Ms. Oliveira allowed her GSW credential to lapse due to non-renewal from September 1, 2009 – December 10, 2009.

4. Ms. Oliveira continued her usual and customary social work responsibilities at her place of employment during the period when her credential had lapsed. Ms. Oliveira continued to put the designation “GSW” at the end of her name during the period when her credential had lapsed.

5. Ms. Oliveira did not tell her employer or others that she was practicing with a lapsed credential.

WHEREAS, by allowing her credential to lapse by non-renewal and by continuing to practice social work using a lapsed credential from September 1, 2009 – December 10, 2009, Ms. Oliveira has violated her professional and ethical duty as set out in Louisiana Social Work Practice Act La R.S. 37:2720(A)(1), which states that it shall be a misdemeanor to practice social work without being licensed; La. R.S. 37:2715(B), which provides that individuals who have current, valid certification may practice social work; La. R.S. 37:2720(A)(2), which makes it a violation to imply or state that one is a GSW unless he is duly licensed as such; and La. R.S. 37:2720(A)(3), which makes it a violation to use a designation with one’s name to imply licensure during the time the license had lapsed. These actions also constitute a violation of Rule 119(B) of the Board’s Rules, Standards and Procedures.

WHEREAS, the credentialed social worker has indicated her desire to resolve this matter through a Consent Agreement and Order;

WHEREAS, the undersigned Assistant Attorney General has conducted an interview with the respondent who has indicated her desire to resolve this matter through a Consent Agreement and Order;

WHEREAS, the credentialed social worker agrees not to repeat the misconduct mentioned in this Consent Agreement and Order, and such repeated misconduct will be considered a violation of the terms of this Consent Agreement and Order.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the Board by La. R.S. 49:955(D), the Board orders and Ms. Oliveira accepts the following administrative action which is a final decision pursuant to La. R.S. 49:958:

1. Ms. Oliveira shall complete a total of three (3) hours of continuing education on the subjects of ethics. This continuing education is in addition to the annual twenty (20) hours of continuing education required to maintain her GSW. Ms. Oliveira shall provide the Board with evidence of attendance within one (1) year after all parties sign this Consent Agreement and Order.
2. Ms. Oliveira shall pass the Board's Open Book Examination on the Social Work Practice Act and Rules, Standards & Procedures within ninety (90) days after the date that all parties sign this Consent Agreement and Order. Ms. Oliveira shall be responsible for all costs associated with the Open Book Examination.



3. Ms. Oliveira shall pay the investigative and legal costs associated with Complaint 2010-59(C) in ^{an amount not to exceed} ~~the amount of~~ \$803.34 (Eight Hundred Three Dollars and 34/100) ^{six months (180 days)} within ~~ninety (90) days~~ that all parties sign this Consent Agreement and Order.
There shall be no pre-payment penalty.
4. Ms. Oliveira specifically acknowledges that failure to comply with the terms of the Consent Agreement and Order may result in a suspension or revocation of her license. The admissions contained herein will be considered proven and the only issue will be failure to follow the terms of the Consent Agreement and Order.
5. By agreeing to the terms of this Consent Agreement and Order, Ms. Oliveira waives all rights to appeal this adjudication.

THIS CONSENT AGREEMENT AND ORDER is a matter of public record for violation of the above referenced sections of the Louisiana Social Work Practice Act and the Rules, Standards and Procedures. The terms of this Consent Agreement and Order may be published and reported, including but not limited to, the LABSWE Newsletter, the Association of Social Work Boards (ASWB), and the National Practitioner Data Bank-Healthcare Integrity and Protection Data Bank (NPDB-HIPDB).



I further acknowledge my awareness that should the Board approve this Consent Agreement and Order that the Order will become a matter of public record.
