I am writing to the LBSWE with regards to a 2015 disciplinary action on my record. That year, I did not complete my CEU requirements on time. My LMSW was suspended until I went through the steps to have the license renewed.

Since that time, I have earned my LCSW. I have been attempting to gain experience working part time doing Telehealth Counseling. However, the agency that hired me several months ago has not gone forward with the onboarding process and other agencies have turned down my applications.

I am concerned this history is affecting my ability to find employment. I am hoping that since this was several years ago and did not involve misconduct with a client, that this could be removed from my record. I was also told by MDstaffers that they a disciplinary report, but could not find information on the board.

I have also applied for an NPI number. I answered to 'NO' to the questions regarding discipline and licensure. I received notice that an insurance company found that I answered 'No' to a question regarding being reported to The Practitioner Data Bank or Healthcare Integrity and Protection Data Bank. I went into the NPI system and changed the answer to yes.

My questions are, was I reported to either of these agencies for the 2015 suspension? Was I reported by LBSWE or someone else? And do I need to answer that I have had a disciplinary report made against my license, although it was my LMSW? Is this always going to prevent me from finding employment?





§ 2707 Qualifications; licensed masters social worker

B. An individual licensed as a licensed master's social worker may engage in advanced social work practice based on the application of social work theory, knowledge, ethics, and methods to restore or enhance social, psychosocial, or biopsychosocial functioning of individuals, couples, families, groups, organizations, and communities. The licensed master's social worker's practice requires the application of specialized knowledge and advanced practice skills which include prevention or intervention, or both, service or treatment planning and evaluation, case management, information and referral, counseling, employee assistance services, addiction services, advocacy, teaching, research. supervision, consultation, community organization, and the development, implementation, and administration of policies, programs, and activities. A social worker licensed at the licensed master's social worker level may practice clinical social work and psychotherapy within an agency under the supervision of a licensed clinical social worker. A licensed master's social worker may work as an employee only in an agency setting. Notwithstanding the definition of "agency" as defined in R.S. 37:2703(1) or the requirement for employment in an agency setting provided in this Subsection, a licensed master's social worker shall be permitted to provide social work services on behalf of a federal, state, or local governmental agency on a contractual basis.

To the Board of Social Work Examiners:

I am writing to request a walver of my continuing education requirements for the period July 1, 2020 through June 30, 2021. Pursuant to Section 2714(0) of the Louisiana Practice Act (Continuing Education and Jucense, Certificate, and Registration Renewal), "[I] response to a disaster or emergency declared by the governor of the State of Louisiana, continuing education units required for renewal of a license may be walved by the board." As shown below, I have been impacted by multiple qualifying disasters/emergencies, each attypisely impacting my ability to complete the Board's continuing education requirements.

Builing the period fully 1, 2020 through June 30, 2021, I have lived in areas impacted by disaster/entergency declarations. Beginning around 2015, I lived in Lake Charles, Louisiana until Hurricane Laura made landfall in Louisiana as a Category 4 storm on August 27, 2020. Louisiana's Governor declared his first State of Emergency related to Hurricane Laura on August 21, 2020 (Proclamation Number 308 IBE 2020), with many continuances thereafter. My home sustained hundreds of thousands of dollars of damage from Hurricane Laura, and recovery is ongoing. After moving multiple times, we lived in New Orleans from October through Detember 2020: Duting that time, Hurricane Delta made landfall near Lake Charles on October 9, 2020, resulting in further damage to our home. While living in New Orleans, Hurricane Zeta, a Category 3 storm, made landfall hear there on October 28, 2021. Louisiana's Governor Issued disaster/emergency declarations for Hurricanes. Delta and Zeta with multiple continuances for each. Thave been Indirectly Impacted by disaster/emergency declarations in the Lake Charles area from the winter storm in february. 2021 and flooding in May, 2021, specifically with respect to availability of contractors to work on our repairs from Hurricanes Leura and Delta. Louisiana's Governor also issued disaster/emergency declarations for these extreme weather events:

I first obtained my social work license in Louisiana in 1996. During the Years for which I held a Louisiana license, I have never requested a walver for any reason, believing that this remedy is to be used only in extraordinary circumstances. Indeed, my circumstances for the noted time beriod have been extraordinary, and for all the reasons noted herein, I respectfully request that the poor dexpeditiously grant this request
