PUBLIC COMMENTS

Public comments were allowed for each agenda item. There were questions posed during this time relative to how to document continuing education for attending board meetings.

ASWB 2020 EXAM RATES

Board members and staff reviewed the ASWB 2020 national and Louisiana's pass rates. Concern was expressed regarding the pass rate percentages. The process for obtaining scores per university was discussed. Ultimately it was determined that the Board will not request exam information for individual universities as this is not a Board function.

OPEN MEETING LAW AND WHAT CONSTITUTES A PUBLIC COMMENT

This was a follow-up discussion from the previous strategic planning meeting. Evan Bergeron recommended that Google Forms be used as a tool for making a public comment. Board members discussed allowing public comment for a specified amount of time for each agenda item. There was no action taken pending feedback from board counsel.

CRIMINAL BACKGROUND CHECKS FOR THOSE LICENSED PRIOR TO JANUARY 1, 2011

This was a follow-up discussion from the previous strategic planning meeting. At this time the Board is not going to move forward with requiring criminal background checks of all social workers licensed prior to January 1, 2011. The Board has authority to obtain a criminal background check prior to renewing a license so it will utilize that route if

determined necessary. Consultation will be made with legal counsel to determine if the investigation of a complaint can require a criminal background check of a respondent.
