Minutes of the Meeting of the Louisiana State Board of Social Work Examiners January 14, 2022

inquiry regarding ongoing relationship with a student after providing services in a school setting. Referred to Rules in 113 regarding Social Work Relationships. If standards have not been updated, the standing standards guide best practices.

Melanie Bouie submitted an inquiry seeking advice relative to a report of abuse and whether it is required that she report to authorities. Referred to 111.D

Scott Gray, LCSW

Scott Gray submitted an inquiry regarding delivering medication. The Rules, Standards and Procedures, allow a social worker to deliver a previously dispensed medication in accordance with Rule 117B. Board reviewed the Pharmacy Board's definition of dispense, R.S.27.1164. Public comment was heard on this matter.

Tyshica Lofton submitted an inquiry regarding how the "no surprise act" applies to social workers. Board advised that person speak to attorney regarding how to interpret this legislation for her practice.

Administrator and Counsel follow-up with Certemy as per Emily and Sherri 12/20/2021 sent a detailed letter addressing outstanding issues. Subsequent telephone conference to review. Follow-up correspondence is that there are things that cannot be corrected this calendar year. The disciplinary module will not be available. Offered to reduce cost by \$15,000 due to inability of disciplinary module inability.

 Licensing number Large development effort and would not commit this year, possibly the following year. May be able to do it in 2023

- Authorize.net payment module up-1st guarter 2022.
- CE Marketplace Course Offerings providers availability to post course offerings: can update this quarterly for us in 2022.
- CE changes requested: edit hours after steps complete in renewal for collection period. Likely by end of 2022 but cannot commit
- Annual cost of \$42,736. Reduction of \$7,500 for first two years applied to Year 2. Recommendation by Sherri that deadlines to make program more functional for us be put in writing. The first payment included a one-time fee of \$3000 for the website. The contract term ends in 2025.
