 - Occupational licensing to protect the public health, safety and welfare has been seen as necessary since as early as 1889 with Dent v West Virginia. Legislative and policy trends in 2023 at the state level include mobility and universal licensing bills as well as deregulation. There is movement for a stronger burden of proof on boards for denial of a license and proposing rules; in addition boards are being asked to defend its rules. Another trend is a one-size-fits-all mentality to reduce differences between professionals. Boards are also experiencing free speech challenges leaving boards to ask is the right to free speech so powerful it (1) allows unlicensed individuals to practice a professional for which they lack qualifications in the context of a professional fiduciary relationship and (2) trumps a state's ability to protect the health, safety, and welfare of the public?
