CONSENT AGREEMENT AND ORDER

WHEREAS, Leigh Ann O'Brien ("Ms. O'Brien") is a credentialed social worker subject

to the jurisdiction and the rules and regulations of the Louisiana State Board of Social Work

Examiners ("Board" or "LABSWE");

WHEREAS, on May 25, 2022, a complaint against Ms. O'Brien was filed with the Board

by an individual who was involved in a custody evaluation with Ms. O'Brien as the mental health

evaluator. The complaint described concerns about Ms. O'Brien engaging in unprofessional

and/or unethical conduct, including (1) failing to submit accurate evaluation reports; (2) failing to

timely submit evaluation reports; and (3) failing to complete necessary forms related to an

evaluation;

WHEREAS, by letter dated June 13, 2022, the Board notified Ms. O'Brien of the

complaint filed against her, provided Ms. O'Brien with a summary of the nature of the complaint,

and requested that Ms. O'Brien, within fifteen (15) days, provide a written response giving her

review of the allegations raised in the complaint;

WHEREAS, by correspondence dated June 30, 2022, Ms. O'Brien responded to the

complaint, giving her response to the allegations contained therein;

WHEREAS, by correspondence dated September 12, 2022, Emily DeAngelo, Board

Administrator, notified Ms. O'Brien of an amendment to the original complaint and requested that

Ms. O'Brien submit additional documentation to support her statement that the Board

recommended she should not testify in the judicial proceeding between complainant and

complainant's husband regarding custody of their minor daughter because of a conflict of interest

within ten (10) days;

WHEREAS, by correspondence dated September 27, 2022, Ms. O Brien responded to the

Board Administrator's request for additional documentation to support Ms. O'Brien's statement

that the Board recommended she should not testify due to a conflict of interest;

WHEREAS, pursuant to a complaint and an administrative investigation, Ms. O'Brien has

indicated her desire to resolve this matter through a Consent Agreement and Order as provided for

in Rule No. 907 of the Board's Rules, Standards and Procedures and La. R.S. 49:955(D) of the

Louisiana Administrative Procedure Act;

WHEREAS, Ms. O'Brien has admitted to the following:

1. Ms. O'Brien is a Licensed Clinical Social Worker ("LCSW") licensed by the Board to

engage in the practice of social work in the State of Louisiana pursuant to the Social

Work Practice Act, La. R.S. 37:2701 et. seq., as evidenced by License Number 4459.

2. Ms. O'Brien was appointed as the mental health evaluator in the case between

complainant and complainant's former husband to make a recommendation regarding

custody of their minor child.

3. Ms. O'Brien did not follow up with complainant to ensure that various forms related to

the custody evaluation were completed and signed.

4. Ms. O'Brien did not submit her evaluation report in a timely manner, which she alleged

was due to COVID-19.

5. Emily DeAngelo, Board Administrator, informed Ms. O'Brien that Ms. O'Brien could

decide whether to testify and that no statute or rule prevented her from doing so.

WHEREAS, by (1) failing to timely submit evaluation reports; and (2) failing to complete

necessary forms related to an evaluation, Ms. O'Brien violated La. R.S. 37:2717(A)(5) and La.

Admin. Code tit. 46:XXV §111(G)(5).

WHEREAS, undersigned counsel has confirmed Ms. O'Brien's desire to resolve this

matter through a Consent Agreement and Order;

WHEREAS, Ms. O'Brien agrees not to repeat the misconduct mentioned in this Consent

Agreement and Order, and acknowledges that any further misconduct mentioned in this Consent

Agreement and Order will be considered a violation of the terms of this Consent Agreement and

Order and shall be cause for further disciplinary action;

WHEREAS, Ms. O'Brien recognizes her right to have an administrative adjudication of

the charges outlined in the complaint and notice letter, at which time Ms. O'Brien would be entitled

to be represented by legal counsel, to call witnesses, and to present witnesses on her behalf in

defense or in mitigation of the charges made, and to a decision thereon by the Board based upon

written findings of fact and conclusions of law in accordance with the Louisiana Administrative

Procedure Act. Ms. O'Brien nonetheless waives her right to formal adjudication and, pursuant to

La. R.S. 49:955(D), consents to the entry of the Consent Agreement and Order set forth hereinafter.

Ms. O'Brien also acknowledges that she waives any rights to which she may be entitled pursuant

to the Louisiana Administrative Procedure Act, La. R.S. 49:951, et seq., or which she otherwise

may be afforded by any law, to contest her agreement to, or the force and effect of this Consent

Agreement and Order, in any Court or other forum.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the

authority vested in the Board by La. R.S. 49:955(D), the Board orders and Ms. O'Brien accepts

the following administrative action which is a final decision pursuant to La. R.S. 49:958:

1. The LCSW license of Leigh Ann O'Brien to be engaged in the practice of social

work in the State of Louisiana, as evidenced by license number 4459 shall be, and

is hereby REPRIMANDED. Accordingly, Ms. O'Brien accepts and shall maintain

strict compliance with the following terms and conditions.

2. Ms. O'Brien shall complete a total of six (6) hours of continuing education on the

subject of documentation. These hours are to be pre-approved by the Board prior

to completion. These continuing education hours must be completed in addition to

all standard renewal requirements for her LCSW licensure. Ms. O'Brien shall

provide the Board with evidence of attendance within twelve (12) months after all

parties sign this Consent Agreement and Order.

3. Ms. O'Brien shall pay a fine in the amount of FIVE HUNDRED DOLLARS AND

00/100 (\$500.00) within one (1) year from the date all parties sign this Consent

Agreement and Order. The payments shall be made on a quarterly basis with the

first payment due within ninety (90) days from the date all parties sign this Consent

Agreement and Order. Payment shall be made by credit card, certified check, or

money order.

4. Ms. O'Brien shall pay all costs associated with Complaint No. 2022-99 in the

amount of \$1,112.50 within twelve (12) months after the date all parties sign this

Consent Agreement and Order. The payments shall be made on a quarterly basis with the first payment due within ninety (90) days from the date all parties sign this Consent Agreement and Order. The payments shall be made by credit card, certified

check, or money order.

5. Ms. O'Brien specifically acknowledges that failure to comply with the terms of this

Consent Agreement and Order may result in a denial, revocation, or suspension of

any license, certificate, or registration issued by, or applied for, in accordance with

La. R.S. 37:2717.

6. Ms. O'Brien shall report the terms of this Consent Agreement and Order to any

board or agency with which she is licensed or registered.

7. By agreeing to the terms of this Consent Agreement and Order, Ms. O'Brien waives

all rights to appeal this adjudication.

Effect of Non-Acceptance of Agreement. Ms. O'Brien acknowledges that this Consent

Agreement and Order is subject to the approval of the Board. She further acknowledges and agrees

that if the Board rejects this Consent Agreement and Order, it will be void, and an Administrative

Complaint may be filed relative to the allegations contained herein. If this Consent Agreement and

Order is rejected by the Board, it will not constitute a waiver of Ms. O'Brien's right to a hearing

on the matters alleged in an Administrative Complaint and the admissions contained herein will

have no effect. She further agrees that if the Board rejects this Consent Agreement and Order, the

members of the Board may decide the matter after a hearing, and their consideration of this

Consent Agreement and Order shall not alone be grounds for recusal of any member of the Board,

including any claims that the Board is biased against her, that it cannot fairly decide the case, or

that it has received ex parte communication.

The prosecutor acknowledges negotiation and preparation of this Consent Agreement and Order in order to resolve, with prejudice, all matters for which the social worker could be charged under Complaint No. 2022-99, and further certifies that this Consent Agreement and Order is consistent with the evidence, adequately addresses the complaint, and represents a true and correct statement of that which could be proven at a hearing of this matter.
