



Dear State Board members,

I have had the pleasure of knowing and working with Elizabeth Wilson for nearly twenty years. We met at a week-long training on Community Crises Response. This led to Dr. Wilson, myself, and a few other colleagues developing a local community crises response team. Since then we have worked together on numerous occasions.

Much of my experience working with Dr. Wilson was at William Woods University, where she was, at the time, the Program Director for their Bachelor of Social Work Program. I worked there as an adjunct instructor in the program. I also served on the program's Advisory Board and was the President for a period of time. Dr. Wilson demonstrated expertise in social work accreditation, social work curriculum development and assessment. The Counsel on Social Work Education spoke highly of her and the program during their site visit. ### Dear LABSWE,

It is my privilege to correspond with you in support of the application from the MSW Program at Herzing University. As you know, Herzing is seeking credentialing to become an authorized Continuing Education Approval Organization in the state of Louisiana. Under the direction of MSW Program Director Dr. Elizabeth Wilson, Herzing University is well aligned to coordinate and administer all aspects of continuing education for your state.

I have known and worked with Dr. Wilson since 1994 in various direct social work practice capacities, as well as a faculty member for the University of Missouri School of Social Work. She became the William Woods University (WWU) BSW Program Director in 2008 where we worked together daily as my supervisor and colleague until 2022. Dr. Wilson's leadership in our program and on campus was exceptional, and earned her promotions to Full-Professor and a tenured faculty member. Her influence upon students and faculty continues to resonate today.

Prior to employment with WWU (2004), Dr. Wilson and I served on a team that developed and coordinated the first Missouri Victim Assistance Academy. This was a 40 hour certificate program with participants from across the State of Missouri. The Academy organized expert speakers and trainers to provide information, training and activities regarding the field of crime victimization. The Academy was highly successful and merged as a partner with the Missouri Association of Prosecuting Attorney's.

Dr. Wilson developed the continuing education component for the Academy that helped legitimize its leadership in crime victimization education.

Dr. Wilson has taken the initiative to develop, organize and administer other trainings and education endeavors for Missouri and WWU. In 2009, she worked with the National Organization for Victim Assistance (NOVA) to coordinate their 40 hour, Community Crisis Training Program for first responders, victim service providers, community members and students. The training was hosted by WWU and provided room and board for attendees that were not local. In 2016, Dr. Wilson worked with a private donor and chaired a committee that developed a Diversity Symposium-Conversations on Gender and Race for the WWU campus and surrounding community. This symposium continued annually through 2021 when resources were no longer available. In 2020, Dr. Wilson initiated a four-part discussion forum by Zoom to educate and provide discussion around race, discrimination and equity after the George Floyd tragedy. Participants from multiple states joined in this offering. From this, Dr. Wilson formed and chaired a WWU committee that established the WWU Multicultural Enrichment Center and Black Student Union on campus.

With Dr. Wilson's 25 years of experience providing social work education and continuing education at local, regional, state and national levels, she has repeatedly proven the understanding of adult learning models and the ability to deliver continuing education. Her resources in the national social work community have allowed her to assess qualified presenters and develop appropriate professional curriculums that serve the needs of professional social workers. Dr. Wilson has the support from Herzing administration as well as her faculty who are all educated at the PhD level and who are Licensed Clinical Social Workers. These faculty are committed in assisting with CEUs and professional development opportunities to ensure social workers maintain professional competency.

Additionally, Dr. Wilson has completed multiple Council on Social Work Education (CSWE) Self-Studies for re-accreditation. These involved assessment and development of curriculum as well as other aspects of program administration. She was hired as a consultant for Herzing University to initiate the development of their MSW Program, and was subsequently hired as the Director of the MSW Program. She wrote the curriculum and assessment plan, hired faculty and lead Herzing through the CSWE Accreditation process. Herzing University has achieved Candidacy for Accreditation by the Council on Social Work Education's Commission on Accreditation. All of this was under the direction of Dr. Wilson

Considering Dr. Wilson's pedigree in social work education, her experiences and successful completion of multiple educational endeavors, I have no reservations regarding her ability to professionally, competently and successfully administer all aspects of continuing social work education for the State of Louisiana. I would strongly

encourage the Continuing Education Approval Organization for Louisiana to consider credentialing Herzing University with this status.

#### Dear Board Members:

I am writing this letter as an appeal of a recent determination. I was denied reinstatement of clinical social work license.

I would like to begin with providing you with some information about my social work experience. I graduated from Tulane University with a master's degree in social work. I then began working as the social worker on an inpatient children's psychiatric unit. I focused on working with children, adolescents, and their families during my internship at the New Orleans children's inpatient psychiatric program. I quickly realized that this was the type of social work I wanted to pursue and specialize in. When I began working as an MSW, I immediately began supervision toward my license and prepared to take the social work examination. I later was named as the Program Coordinator for Children's Services and completed the requirements and received my license to practice independently. I subsequently moved back to New Orleans and began working at DePaul Hospital as a social worker on the children's inpatient psychiatric unit. A year after beginning at DePaul, I was named Assistant Service Director over inpatient and outpatient services for children and adolescent which covered all inpatient and residential services. I was later appointed as the Service Director over this area. At the same time, I was a therapist in a private practice working with other social workers and psychiatrists specializing in children, adolescents and their families. I also worked with the faculty of Tulane University and LSU School of Medicine in their child psychiatry program.

I was then provided with the opportunity to join Our Lady of the Lake to develop their child and adolescent services. I established the Family Center which is now part of the Our Lady of the Lake Children's Hospital and worked directly with the psychiatrists that continue to service the community today. I also developed inpatient services for adolescents. At Our Lady of the Lake, I began taking on more administrative duties over time which led to me eventually becoming Vice President of the medical center. I eventually moved on to other health care settings in a variety of administrative, executive and consultive roles.

I would like to also note that during the time I was active as clinical social worker, I provided supervision to several MSWs. I also served as the supervisor for social work interns.

After selling my interest in a business that I had started with several others, I decided to take a couple of years to help take care of our adopted grandbaby. The baby is now three and recently started school. After much reflection and input from those closest to me, I decided to look into reinstatement of my clinical social work license. I have always believed that as a social worker, working with children, adolescents, and their families, I best utilized my gifts and talents and leveraged my extensive clinical experience. I thought that I had let my license lapse when I was working as Vice President at Our Lady of the Lake because I did not complete the required CEUs.

I reached out to the Louisiana Board of Social Work Examiners in October of 2022 to determine if it was possible to reinstate my license and if so, what the process was to do so. I was provided the following information by email:

I have assigned a reinstatement application to your account for your completion. According to Rule 2714, the following are required:

**Rule 2714** 

E. If any license, certificate, or registration is lapsed for more than sixty months, the applicant for license, certificate, or registration shall submit proof of completion of forty hours of approved social work continuing education and pass the board exam on the Louisiana Social Work Practice Act and the rules, standards, and procedures prior to reinstatement. Continuing education requirements for LCSW applicants shall include at least twenty hours of clinical content and three hours of ethics training. Continuing education requirements for LMSW and RSW applicants shall include at least three hours of ethics training.

I then called the Board to ensure that I understood the process and requirements as well as the system used to document the process and CEUs. Once I had validated the process, I began to diligently work on completing my CEUs as required for an LCSW. I completed 40.25 hours of CEUs and then provided the information and forms for my background check. Once the background check was complete, I took the exam required and provided my score. I understood at this point that I had satisfactorily completed all the requirements to reinstate my clinical social work license. I contacted the Board again to validate my understanding and was told my application for reinstatement was pending Board approval. The credential program also reflected this status.

I received no further communication from the Board. After a period of time, I noted that my status in the credentialing system had changed and believed that this indicated that my clinical license had been reinstated. I was surprised to learn that this was not the case.

I then contacted the Board by email and then a couple of days later by phone to inquire about resolving this obvious error. I was told that the situation needed to be investigated and I would be called back. I did receive a call back shortly thereafter, but I was on another phone call and the call went to voicemail. When I finished with my call, I immediately called the Board back but went to voicemail. I then listened to voicemail which indicated that I was not eligible for reinstatement of my clinical license and would need to complete 2 years of supervision and retake the social work exam. I then called the Board again and left a message requesting that someone contact me as soon as possible. I did not receive a return call.

Ten days after I sent the email noted above, I received the following in an email in reply:

Please see the attached letter mailed to you in 2001. You will have to apply to take the Clinical level exam which should be done through the LCSW application on our website. The first phase of the LCSW application is the supervision portion. I added one to your account for you. After this has been completed and approved by our office, you will then move to the application for board review for test approval.

The letter referenced is provided as an attachment. I had in fact received the letter referenced although initially I did not recall receiving it.

I further inquired by email and was provided with the following in an email:

However, the license you held when your license was active was called GSW, but the name has since changed to LMSW. A LMSW reinstatement application is the correct application that should have been completed being that LMSW is the level of licensure that you had. Your LMSW licensure was reinstated on 01/13/2023 after completion and approval of your LMSW reinstatement application. Being that your license lapsed, you will have to pass the clinical level exam to be granted LCSW licensure. Laws and requirements change over time and at this time, a LCSW application completion and test approval from such is required for this level of licensure. Please refer to the Social Work Practice Acts for current requirements:

§2708. Qualification; licensed clinical social worker A. No individual shall be eligible for licensure by the board as a licensed clinical social worker unless the individual: (1) Is of good moral character and whose screening for criminal history pursuant to R.S. 37:2710 contains no disqualifying information. (2) Holds a master's degree from an accredited graduate school of social work. (3) Has completed at least three thousand hours of postgraduate social work practice over a minimum of two years and a maximum of four years while under the supervision of a board-approved clinical supervisor. The board shall consider circumstances warranting more than four years to complete this experience requirement. (4) Has passed an examination approved by the board. B. An individual holding the licensed clinical social worker license may independently engage in advanced social work practice based on the application of social work theory, knowledge, ethics, and methods to restore or enhance social, psychosocial, or biopsychosocial functioning of individuals, couples, families, groups, organizations, and communities. The practice of clinical social work requires the application of specialized clinical knowledge and advanced clinical skills in the areas of prevention, assessment, diagnosis, and treatment of mental, emotional, and behavioral and addiction disorders. Treatment methods include the provision of individual, marital, couple, family, and group psychotherapy. The practice of clinical social work may include private practice, employee assistance and addiction services, and the provision of clinical supervision. A licensed clinical social worker may work as an employee in a practice setting or independently in private practice.

The license I held at the time I let my license lapse was not a GSW. I was a licensed clinical social worker at the time my license lapsed.

I apologize for this lengthy letter. I wanted to provide an accurate and complete outline of the situation.

I am requesting that my clinical social work license be reinstated. I entered into this reinstatement process in good faith and adhered to the requirements as outlined to me both by email and verbally. This obviously took significant time and energy as well as financial commitments. I hold a master's degree from an accredited graduate social work program. I then completed the supervision requirements in a two-year period and passed the examinations. I have many hours oficlinical social work practice. I held a license as a clinical social worker and practiced as an independent clinical social worker for many years and in many settings. I followed the exact instruction provided to me by the Board for reinstatement of my clinical social work license.

The team members that I have spoken to at the Board have been courteous. The process unfortunately has been flawed.

I appreciate the time and attention of the Board and anxiously await your decision.

Historical Notes for Anna Silva to help clarify the situation.

Anna Silva was issued a BCSW (Board Certified Social Work) on April 4, 1988 after completing 2 years of supervised practice and passing the AASSWB Level C exam.

When the Practice Act was amended in 1999, BCSWs were required to submit an affidavit acknowledging that they wanted the LCSW. If an affidavit was not received by December 31, 2000, the BCSW was reverted to GSW (Graduate Social Work). An affidavit was not received and her BCSW was changed to GSW.

Anna also did not renew, and her credential lapsed effective August 31, 2000.

Through legislation passed in 2010, on January 1, 2011 everyone with the license type GSW was switched to LMSW.

When Anna called about reinstating her license a check of the database showed that she held a LMSW that lapsed in 2000 so she was assigned the LMSW Reinstatement application. That application was approved at the January 2023 board meeting and the LMSW was reinstated. She did not receive a denial letter or we would have offered her a compliance hearing.

At the time that she called there was nothing in the database to indicate she held the BCSW at one time. We pulled her paper file after getting contacted by her about why she wasn't issued the LCSW.

Supervisee—any person under the supervision of a credentialed social worker. The supervisee may be an applicant for social work credentials, an employee under the supervision of the LCSW, GSW or RSW, or a person who contracts with the licensed social worker for supervision.

Supervision within an Agency—the professional relationship between a supervisor and a social worker that provides evaluation and direction over the services provided by the social worker and promotes continued development of the social worker's knowledge, skills, and abilities to provide social work services in an ethical and competent manner.

Supportive Counseling—the methods used by social workers to help individuals create and maintain adaptive patterns. Such methods may include building community resources and networks, linking clients with services and resources, educating clients and informing the public, helping clients identify and build strengths, leading client and community groups, and providing reassurance and support.

### §303. Practice

- A. Social Work Practice. Any person practicing social work without license, certification, provisional certification, or registration is subject to the provisions of R.S. 37:2720, including injunctive proceedings and prosecution.
- B. Independent and Private Practice. Only a licensed clinical social worker may engage in the independent and private practice of social work.
- C. Graduate Social Workers, Provisional Graduate Social Workers and Registered Social Workers shall not:
- 1. contract directly with individuals, couples, families, agencies or institutions for clinical services, consultation, supervision or educational services;
  - 2. bill for services rendered;
  - 3. receive direct payment for services;
  - 4. claim to be licensed or in private practice.
- D. Graduate Social Workers and Provisional Graduate Social Workers may:
- 1. practice clinical social work within an agency under the supervision of a licensed clinical social worker and shall meet the supervision requirements of Chapter 5, Minimum Supervision Requirements, §505.
- E. Applicants for registration, certification, or licensure who indicate on their application that they have been employed for more than 120 days as a social worker in the state of Louisiana are subject to the provisions of R.S. 37:2720.

- F. An applicant who meets all the requirements of R.S. 37:2706, 2707, or 2708 and who has worked more than 120 days as a social worker in the state of Louisiana and who has not otherwise violated any part of R.S. 37:2701-2723 or its rules, shall be offered the following in the form of a consent order and agreement in order to process the application:
- 1. completion of five pre-approved continuing education hours in ethics to be completed within 90 days of issuance of the registration, certification or license, in addition to the 20 clock hours of continuing education required for the annual renewal of the registration, certification or license; and
- 2. passing score on an open book examination on the Louisiana Social Work Practice Act and the *Rules, Regulations and Procedures*, which include the Standards of Practice for Social workers within 90 days of the date the Consent Order and Agreement is signed;
- 3. the consent order and agreement shall not be considered disciplinary action and shall not be reported to the professional organizations or published in the board's newsletter.
- G. In accordance with R.S. 37:2709, which states in part that the license, certificate, provisional certificate, or registration shall be kept conspicuously posted in the office or place of business at all times, it is permissible to post the original certificate of license, certification, provisional certificate of license, certification, provisional certificate of license, certification, provisional certification or registration, or the current identification card received from the board upon renewal of the license, certification, provisional certification or registration.

# §305. Qualifications for Registration, Certification, Licensure

- A. Registered Social Worker (RSW)
  - 1. Must be of good moral character.
- 2. The applicant shall have his/her university submit official transcript indicating the receipt of a bachelor of social work, bachelor of arts, or bachelor of science degree from an undergraduate social work program, accredited by the Council on Social Work Education, or a master's degree of social work from a graduate social work program, accredited by the Council on Social Work Education.
  - B. Graduate Social Worker (GSW)
    - 1. Must be of good moral character.
- 2. The applicant shall have his/her university submit official transcript indicating the receipt of a master's degree of social work from a graduate social work program, accredited by the Council on Social Work Education.

- 3. The applicant shall obtain a passing score on an examination approved by the board.
- 4. Grandfather Period: The board shall waive the examination requirement for applicants who submit a completed and notarized application and appropriate fee at any time within one calendar year from January 1, 2000.
- C. Provisional Graduate Social Worker (Provisional GSW)
- 1. The board may issue provisional certification to an applicant who meets all requirements for the GSW certification except for passing the examination approved by the board.
- 2. The individual may hold the provisional certificate for up to three years from the date of issuance of the original certificate provided the individual takes the examination approved by board at least once each year.
- 3. It is the responsibility of the Provisional GSW to submit proof of examination to the board office once each year of eligibility.
- 4. The Provisional Graduate Social Worker who does not pass the credentialing examination for the GSW certification within three years from the date of issuance of the original certification may apply for the registered social work.
  - D. Licensed Clinical Social Worker (LCSW)
    - 1. The applicant must be of good moral character.
- 2. The applicant shall have his/her university submit official transcript indicating the receipt of a master's degree of social work from a graduate social work program, accredited by the Council on Social Work Education.
- 3. The applicant shall submit documentation verifying at least 36 accumulated months of full-time post graduate social work practice on a form provided by the board.
- 4. The applicant shall submit documentation verifying at least 24 accumulated months of supervision post graduate social work experience in accordance with the board's supervision rules and on the form provided by the board.
- 5. Supervised experience must be under the supervision of a board-approved clinical supervisor.
- 6. The applicant shall obtain a passing score on an examination approved by the board.
- E. Board certified social workers who hold valid, current licenses on January 1, 2000, must submit an affidavit to the board on or before December 31, 2000, requesting that their status be changed to licensed clinical social worker. Board certified social workers who do not submit an affidavit by December 31, 2000, will be assigned the graduate social work status effective January 1, 2001, and shall be subject to the qualifications listed in R.S. 37:2708 to change their status after January 1, 2001.

### §307. Administration of Examination

#### A. Examination

- 1. The social work examination shall be administered at least once per calendar year at a time and place designated by the board.
- 2. The Louisiana State Board of Social Work Examiners recognizes the examinations of the Association of Social Work Boards as the national examination for social workers.
- 3. Examination Pass Point. The board shall administer and grade a written examination or employ a national recognized testing firm to do the same. Whichever method is used, the board will consistently strive to improve reciprocity with other states having licensure comparable to Louisiana. A pass score of 70 will be used to grade the examination for the licensed clinical social worker and the graduate social worker.

### B. Retake of Examination

- 1. Applicants must complete a retake application and submit the retake fee to the board office.
- 2. If more than 18 months have lapsed since the last examination an applicant for retake must submit an updated application for license.
- 3. Applicants for the LCSW license must submit an Employer Verification Affidavit for each place of employment after receipt of the MSW degree.
- 4. The board shall observe the retake policy of the testing service.
- C. Examination Review Policy. The board may allow candidates to review failing examinations, at applicant's expense, in accordance with the rules of the Association of Social Work Boards.

### D. Preparatory Course

- 1. The board shall not endorse nor in any way participate in the operation or planning of any preparatory or cram course allegedly preparing applicants for the social work examination.
- 2. No former member of the Board of Examiners may take part in the development, sponsorship or administration of any preparatory or cram course offered to candidates for the social work examination for two years after said board member's term of office has expired.
