

List of Proposed Rules for Promulgation

The Rules Committee has been working for several years on recommendations for additions and amendments to the Rules, Standards and Procedures. The product from the committee includes referrals from the board, changes in response to the last amendment to the Louisiana Social Work Practice Act enacted on January 1, 2022 (Act 215), and removal of duplicative language. The recommended language is currently undergoing a legal sufficiency review by board counsel. The specific language of the proposed promulgation will be provided to all social workers with a period set for making public comments.

Chapter 1. Standards of Practice

§101 & §103 – changes due to definition of social worker in Practice Act

§111(F)(1) – revising to require written informed consent §113(A) – further clarifies exploitation and includes prohibition of personal, political, or religious agenda of social work §113(B) – provides expanded description of dual relationships §125 – addition addresses social work educators

Chapter 3. General Provisions

§301 – definitions to correlate with rewrite of Chapter 9; definition of client revised for clarification

§305(D) – changes due to changes in Practice Act for LCSW requirements

§307(E) – addition of early testing criteria

§309 – changes address current procedure and eliminates requirements already mandated by the Practice Act

§311 – change adds requirement of listing supervisees on renewal and deletes requirements mandated by the Practice Act

§313 – increases renewal fees and lapsed fees and revises dates to coincide with Practice Act changes

§315 – addresses election of officers

§317 – repeal due to addition of Chapter 11

§319 – rewording only

§323 – addition of inactive status

§325 – addition of emeritus status

§327 – addition of discrimination prohibition language

§329 – addition of rules for public comments

Chapter 5. Minimum Supervision Requirements

§503 – changes due to Practice Act §505(A) – revised to reflect Practice Act

Chapter 7. Impaired Professional Program Authority

Rename program Recovering Professional Program and revise to mirror current procedures

Chapter 9. Procedural Rules

Complete rewrite

Chapter 11. Continuing Education

Adds rules regarding continuing education approval organization, allows for credit for attending LABSWE board meetings and committee meetings, creates a separate section for credit for teaching, and allows for synchronous, interactive webinars to be considered in-person learning

Suicide Prevention Task Force- House Concurrent Resolution 84 of the Louisiana Legislature

As per HCR 84, according to the Suicide Prevention Resource Center of the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration,

- African American adults were at the highest risk for past-year suicide attempts in 2019.
- A suicide rate peaked during the adolescence and young adult life of African American populations from the year 2010 to 2019.
- Among those suicide deaths in the African American population, the suicide death rate for men has reached more than four times the rate of women.
- The state of Louisiana has reported six and four-tenths African American deaths from suicide to every ten-thousand-person population in comparison to the seven and three-tenths rate reported for the United States

Under the leadership of State Representative Edward Jordan, a task force inclusive of our chair Dr. Hyacinth McKee of the Louisiana State Board of Social Work Examiners and other chairs of licensing boards and associations in Louisiana was established to study death by suicide statistics for African Americans in this state and to propose recommendations regarding suicide prevention. Other members on this task force included but are not limited to: Southern University Baton Rouge-Nelson Mandela College of Government and Social Sciences, The New Orleans Chapter of the National Association of Black Social Workers, Louisiana Department of Health: Office of Behavioral Health, Louisiana Chapter of the National Association of Social Workers, Louisiana Chapter of the National Association for the Advancement of Colored People, Louisiana Psychiatric Medical Association, Louisiana Academy of Medical Psychologists and The Baton Rouge Crisis Intervention Center. The Task Force on African American Suicide Rates will submit its findings in the form of a written report to the legislature and the David R. Poynter Legislative Research Library no later than February 1, 2024. Two meetings were held this season whereby the Louisiana Suicide Prevention plan by Dr. Robyn Thomas of LDH: OBH and research provided by LSU Department of Psychiatry and SUBR Nelson Mandela College of Government and Social Sciences were reviewed. The next meeting is scheduled for Wednesday, December 13, 2023, at 10:00 am at the State Capitol Building. It is open to the public.

Committee Information


