### SOUTH CAROLINA BOARD OF SOCIAL WORK EXAMINERS

### **GUIDELINES FOR CONTINUING EDUCATION**

### A. Requirements

- 1. A minimum of 40 clock hours of social work related continuing education is required biennially (every two years) to renew each license.
- 2. A minimum of twenty of the 40 clock hours must be specifically provided by a trained social worker a person with a BSW, MSW, or a doctorate degree in social work.
- 3. The reporting period is from January 1 to December 31 biennially (every two years).
- 4. Hours obtained within the past two years (January 1, 2023 through December 31, 2024) by taking graduate level academic social work courses or participating in social work training within Board parameters, regardless of whether or not you were licensed as a social worker at that time, can be used to meet Continuing Education requirements.
- 5. The Board will waive one license year, continuing education requirements for licensed social workers who are activated in the military for more than 30 days.

### B. Definition of Continuing Education Training

Continuing Education is those social work related activities which are oriented to the enhancement of social work practice, values, skills and knowledge.

- 1. Academic social work courses taken for credit or audit.
- 2. Social work related academic courses taken for credit and audit.

Courses must be in related areas such as: administration, research, psychology, sociology, law, child and family development, counseling, gerontology, substance abuse, criminal justice, mental health, etc.

- 3. Seminars, workshops, institutes, conferences or mini-courses oriented to the enhancement of social work practice, values, skills or knowledge.
- 4. Training specifically related to policies, general procedures, emergency procedures or other related operational procedures of an agency or organization are *not* eligible for continuing education credit.
- 5. A first time presentation of a paper, workshop or seminar for a national, regional or statewide or other professional meeting. Repeated presentations of the same materials cannot be counted as separate activities. One time presentation will count for five continuing education hours.
- 6. Preparation of a paper and acceptance for publication in a recognized social work or related journal. An accepted paper will count for five continuing education hours.
- 7. Preparation of new social work or related courses for an educational institution or organization. A new course will count for five continuing education hours.
- 8. No more than twenty continuing education hours may be counted from Section B, Parts 5, 6, and 7 per biennial renewal year.
- 9. Any audio and/or visual educationally related home study tapes, or professional journals are approved by the Board for independent self-study Continuing Education credit provided:
  - a. Credits are granted by an approved sponsor,
  - b. The approved sponsor administers and scores an appropriate test relating to the educational content
  - c. The licensee passes the test with a score of at least 70% prior to the awarding of Continuing Education credits.

### C. Carryover of Continuing Education Hours

Up to twelve (12) continuing education hours may be transferred from a surplus from the preceding license renewal to the present renewal every two years.

### D. Verification of Continuing Education

- 1. The passing course grade report will constitute verification for academic credit hours.
  - a. One semester hour of academic credit is equivalent to 15 clock hours of continuing education.
  - b. One quarter hour of academic credit is equivalent to 10 clock hours of continuing education.
- 2. A signed statement from the instructor for hours attended will constitute verification for audited courses.
- 3. The Continuing Education Unit or other certificate of attendance will constitute verification of workshops, seminars, institutes or mini-courses.

One CEU (Continuing Education Unit) is equivalent to ten clock (contact) hours.

- 4. A copy of the presentation with a letter of acceptance or copy of the program will constitute verification of the first time presentation and acceptance of presenting at a seminar, workshop, institute, conference or mini-course.
- 5. A copy of the paper with a copy of the letter of acceptance for publication will constitute verification of the preparation and acceptance of a paper for a journal.
- 6. A copy of the course outline with a confirming letter from the dean/director will constitute verification for the preparation of a new social work or related academic course.

### E. Board Approved Educational Institutions, Organizations and Agencies to Provide Continuing Education

The following educational institutions, organizations and agencies are pre-approved as providers for Continuing Education. Attendance in any social work or related continuing education program sponsored by an institution, organization or agency on this list is pre-approved as acceptable toward meeting the South Carolina Board of Social Work Examiner's Continuing Education requirements.

- 4. Other national or state professional associations relating to one s social work or related practice specialty and of which one is a member.
- 5. Licensed Hospitals.
- 6. Any workshop, seminar, institute, conference or mini-course to be provided by other than one of the Board approved groups listed in section E, parts 1, 2, 3, 4, and 5 will also be approved if formally co-sponsored or endorsed by one of the Board approved Educational Institutions, Organizations or State and Federal Agencies listed above.

If the licensed social worker s employer approves/recommends in writing that an employee attend a program presented by an organization other than those listed above, this will constitute formal endorsement of the program and therefore may be counted as Continuing Education credit.

7. Nationally focused human services related conferences sponsored by non-membership based, not for profit organizations will be pre-approved for continuing education credit if such training is social work or social work related in its nature.

#### F. Documentation

- 1. Each licensee shall maintain for three years their own record and evidence of continuing education which they have completed. The Board will not maintain continuing education files for licensees.
- 2. The Board will require that an <u>Affirmation of Continuing Education</u> be signed on the renewal form at biennial license renewal. Documentation of Individual continuing education sessions completed should be retained by the licensee for 3 years and not sent to the Board.
- 3. The Board will conduct a sample audit biennially of individual records and verification of continuing education completed by licensees. The Board may also request from an applicant at license renewal that they provide their records and evidence of continuing education training.

### G. Requests for Sponsorship

An Application for Continuing Education Sponsorship may be obtained from the Social Work website https://www.llr.sc.gov/sw/pub.aspx.

A non-refundable fee of \$25.00 is required for processing on all sponsorship requests. The Board requires that all requests for sponsorship approval be in the Board office no later than 30 days prior to the next scheduled Board meeting and no less than 60 days prior to the first presentation of the workshop. If the application for sponsorship is not received before the 60 day deadline or the 30 day deadline, the workshop will not be approved by the Board.

Board approved sponsor status for each training workshop shall expire (2) years from the date of Board approval and must be renewed by making application to the Board.

The Board retains the right to monitor Continuing Education programs sponsored by Board approved sponsors and will withdraw approval from a sponsor who does not maintain the standards demonstrated in their application.

**RENEWALS** 

SUBCHAPTER A

**GENERAL PROVISIONS** 

**RULE §883.1** 

Renewal of a License

- (a) All licenses subject to the jurisdiction of the Council are renewable on a biennial basis and must be renewed online.
- (b) Renewals are due on the last day of the license holder's birth month, but may be completed up to 60 days in advance.
- (c) Renewal Conditions:
- (1) Licensees must pay all applicable renewal and late fees, indicate compliance with any continuing education requirements, and comply with any other requests for information or requirements contained within the online renewal system as a prerequisite for renewal of a

license. This paragraph is effective for licenses with expiration dates prior to November 30, 2021.

- (2) Licensees must pay all applicable renewal or late renewal fees, indicate compliance with any continuing education requirements, and comply with any other requests for information or requirements contained within the online renewal systems as a prerequisite for renewal of a license. This paragraph is effective for licenses with expiration dates on or after November 30, 2021.
- (d) In addition to the requirements of subsection (c) of this section, licensees must also show compliance with each of the following as a condition of renewal:
- (1) provide or update the standardized set of information about their training and practices required by §105.003 of the Health and Safety Code;
- (2) affirm or demonstrate successful completion of a training course on human trafficking prevention described by §116.002 of the Occupations Code; and
- (3) if chosen for an audit under §882.50 of this title, licensees are required to submit a self-query report from the National Practitioner Data Bank in the same manner required by §882.2 of this title.
- (e) Licensed psychologists must update their online profile information when renewing their license.
- (f) A license may not be renewed until a licensee has complied with the requirements of this rule.
- (g) A licensee who falsely reports compliance with continuing education requirements on his or her renewal form or who practices with a license renewed under false pretenses will be subject to disciplinary action.
- (h) Licensees will be sent notification of their approaching renewal date at least 30 days before their renewal date. This notification will be sent to the licensee's main address via first class mail. Responsibility for renewing a license rests exclusively with the licensee, and the failure of the licensee to receive the reminder notification from the Council shall not operate to excuse a licensee's failure to timely renew a license or any unlawful practice with a subsequent delinquent license.

I am submitting this letter and supporting documentation to request an exemption from obtaining in person CE's for the 2024 renewal of license #16517. I currently reside in Pennsylvania, where I have been a licensed social worker since 2009. As of 2019, PA no longer has an in person requirement for CE's (see submitted documents.). I am currently licensed in Louisiana only because my employer, AmeriHealth Caritas, requires it. Additionally, they require that I maintain licensure in Ohio and the District of Columbia - neither of which have an in person requirement at this time.

I live in a relatively rural area, with the closest city being Pittsburgh. Universities within the city that have a social work department that offer CE's, do not have any in person courses - all are being done virtually. It would be a financial hardship to travel to the other side of PA or out of state for in person CE's. My employer does not offer paid education time to complete CE's, and also does not reimburse for the cost of travel / lodging / meals for CE's. I will gladly substitute in person courses with live virtual courses, given the lack of in person courses available in my region.

### Dear LCSW Board,

Thank you for the opportunity to request a waiver for some of the in person Continuing Education Units for my license renewal. I am an LCSW, originally from Louisiana, but I have lived in California since 1999. I have not worked in the field of social work since about 2002 but I have maintained my licensure and always obtained the necessary CEUs.

This year when I was trying to book CEU classes in person, I had a great deal of difficulty finding them. I was able to find only two in my geographic area (San Francisco Jung Institute, May 11th, for 3 CEUS and on May 24th by PESI for 6.25 hours). However, I found out today that the course at the Jung Institute is now a live virtual format. Given that, I will not be able to complete the full 10 in person hours before my due date. I have called and researched multiple platforms, universities, extension courses, etc. for in person classes and I am not able to find any more. (If you need more information about the places I've contacted, please let me know as I can provide all of the emails, calls and searches.)

Upon further investigation, I believe that the reason I cannot find more in person CEUs in my area is because California license renewal does not require in person Continuing Education. All of their CEUs can be obtained through virtual, or other means. Please see attached document; the last paragraph on page 2 addresses this. ("Licensees may obtain all CE hours through interactive, electronic means. This includes online, teleconferencing and video.")

Given all of the above, I would like to request a waiver for at least four of my in person hours, substituting them for virtual or live online events. Thank you so much for your consideration.

### OVERALL HOURS REQUIRED FOR RENEWAL

You are required to complete a minimum of 36 hours of CE prior to each and every renewal. This includes the first renewal of your initial license.   - As of November 19, 2019, the Board no longer has a live CE requirement. This information is available

You requested that I email you by the end of that week so that my request could be added to this month's LABSWE board meeting agenda. Unfortunately, I did not send the email in time for this months meeting as I mistakenly thought my MSW courses from last year would be countable as 15 hours for inperson CEUs, thus I would no longer need the rural exemption. This was a mistake as those courses were from January to May of 2023 and are outside of this year's collection period. I hope this request can be placed on May's meeting agenda.

My name is Lacey Scarborough. I am an LMSW (License number 17349). I would like to formally request a rural exemption to acquire all my required CEUs (20 hours) through ASWB accredited online/distance learning. The reason for my request is that I live in Deridder, Louisiana and work in a rural community. There are limited in-person CEU opportunities around me. It is very difficult for me to travel to attend these CEUs as I am a single-income household and just had my second child. I have been on maternity leave, for which I had to use PTO and unpaid time off to be able to recover. - <u>012. CONTINUING EDUCATION REQUIREMENTS</u>. During the 24 months prior to the renewal date, individuals holding active licenses and certifications in the State of Nebraska must complete at least 32 hours of acceptable continuing education hours related to mental health practice during the preceding 24-month period.
- <u>012.01 GENERAL REQUIREMENTS</u>. Applicants must meet the following continuing education requirements:
- (A) All license and certificate holders must complete at least 4 hours of continuing education in ethics.
- (B) All licensed independent mental health practitioners must complete at least 6 hours of continuing education relating to diagnosis and treatment of major mental disorders.
- <u>012.02 LICENSEES WHO HOLD AN ASSOCIATED CERTIFICATE</u>. An individual who holds an independent mental health practice license or mental health practice license and an associated certificate(s) is not required to earn continuing education hours for each additional certificate.
- <u>012.03 TYPES OF ACCEPTABLE CONTINUING EDUCATION AND HOUR DETERMINATIONS</u>. The following provides the types of continuing education that is considered acceptable for renewal and reinstatement and the hour determinations:
- (A) Completing academic credit during the renewal period. Academic credit is determined as follows:
- (i) 1 academic semester credit equals 15 continuing education credit hours and 1 credit audited equals 8 hours of continuing education.
- (ii) 1 academic quarter credit equals 10 continuing education credit hours and 1 credit audited equals 5 hours of continuing education.

- (iii) 1 academic trimester credit equals 14 continuing education credit hours and 1 credit audited equals 7 hours of continuing education.
- (B) Hours for teaching an academic course or supervising a practicum or internship is determined the same as 172 NAC 012.03(A) above.
- (C) 6 hours per renewal period can be obtained for supervising a provisional licensee or provisional certificate holder.
- (D) Hours for completing home study or video programs, including those transmitted through electronic means, are determined by the provider of the program.
- (E) Authoring a peer reviewed publication equals 16 hours.
- (F) 60 minutes equals 1 continuing education hour when attending or participating workshops, lectures, or interactive webinars.
- <u>012.04 WORKSHOP PRESENTERS OR ACADEMIC INSTRUCTORS</u>. An individual may receive credit for the initial presentation during a renewal period. Credit will not be given for subsequent presentations of the same program or course.
- 012.05 NON-ACCEPTABLE CONTINUING EDUCATION. Non-acceptable subject matter for continuing education credit includes, but is not limited to the following:
- (A) Leadership training provided through associations;
- (B) Business technology, business techniques, and management; and
- (C) Association business meeting or delegate report.

280.7(2) A person who is licensed in another jurisdiction but who is unable to satisfy the requirements for licensure by endorsement may apply for licensure by verification, if eligible, in accordance with rule 645—19.1(272C).

In lieu of the requirements in paragraphs 280.7(1) "d," "e," and "f," the board will accept the ASWB Social Work Registry verification of academic transcripts, examination scores, and licensure in other states.

### 645-280.9(154C) License renewal.

280.9(1) The biennial license renewal period for a license to practice social work shall begin on January 1 of odd-numbered years and end on December 31 of the next even-numbered year. Every licensee shall renew on a biennial basis. The licensee is responsible for renewing the license prior to its expiration. Failure of the licensee to receive notice does not relieve the licensee of the responsibility for renewing the license.

280.9(2) Renewal procedures.

- a. A licensee seeking renewal shall:
- (1) Meet the continuing education requirements of rule 645—281.2(154C,272C) and the mandatory reporting requirements of subrule 280.9(3). A licensee whose license was reactivated during the current renewal compliance period may use continuing education credit earned during the compliance period for the first renewal following reactivation; and
  - (2) Submit the completed renewal application and renewal fee before the license expiration date.
- b. An individual who was issued a license within six months of the license renewal date will not be required to renew the license until the next renewal two years later.
- c. Those persons licensed for the first time shall not be required to complete continuing education as a prerequisite for the first renewal of their licenses. Continuing education hours acquired anytime from the initial licensing until the second license renewal may be used. The new licensee will be required to complete a minimum of 27 hours of continuing education per biennium for each subsequent license renewal.
- d. Persons licensed to practice social work shall keep their renewal licenses displayed in a conspicuous public place at the primary site of practice.
- e. Failure to receive the notice of renewal shall not relieve the licensee of the responsibility for submitting the required materials and the renewal fee to the board office 30 days before license expiration.
- f. A social worker whose Iowa license is inactive, delinquent, closed, retired, voluntarily surrendered, suspended, or revoked cannot advance to a higher level until the license is again active.

280.9(3) Mandatory reporting of child abuse and dependent adult abuse.

- a. Effective July 1, 2019, a licensee who regularly examines, attends, counsels or treats children in Iowa shall complete an initial two-hour child abuse mandatory reporter training course offered by the department of human services within six months of employment, or prior to the expiration of a current certificate. Thereafter, all mandatory reporters shall take a one-hour recertification training every three years, prior to the expiration of a current certificate.
- b. Effective July 1, 2019, a licensee who regularly examines, attends, counsels or treats adults in Iowa shall complete an initial two-hour dependent adult abuse mandatory reporter training course offered by the department of human services within six months of employment, or prior to the expiration of a current certificate. Thereafter, all mandatory reporters shall take a one-hour recertification training every three years, prior to the expiration of a current certificate.
- c. The requirement for mandatory training for identifying and reporting child and dependent adult abuse shall be suspended if the board determines that suspension is in the public interest or that a person at the time of license renewal:
  - (1) Is engaged in active duty in the military service of this state or the United States.

I request that a copy of documents containing the following information be provided to me: The email addresses of all social workers currently licensed by your state. You should know that I am affiliated with an educational or noncommercial scientific institution, and this request is made for a scholarly or scientific purpose and not for a commercial use. More specifically, I am an assistant professor at the University of Connecticut and will be using the information to conduct a research study of licensed social workers across the county. The study will identify social workers' preparedness to practice and examine how well their social work program and other training opportunities prepared them for social work practice. The findings from this study will shed light on the strengths and needs of our social work workforce, who are the primary providers of mental health services in the United States. To Whom It May Concern:

My name is Amelia Ryland. I am a LMSW working toward my LCSW. On September 9th, 2022 I began the electronic process to prepare for supervision. This process included completing the supervision contract and record log in Certemy. My first supervision session was November 22, 2022. I have completed 62 hours of supervision as of April 4, 2024. Recently, upon contacting the Office of LABSWE to inquire about testing eligibility, a staff member informed me that the board had no record of my supervision contract, although my supervisor and I both recollect completing the contract. Furthermore, staff explained none of the hours accumulated without record of the contract were valid. Technologically, this is a very simple and easy mistake to make, but the consequences are dire. I am overwhelmed considering the financial, professional, and emotional effects of this error. I was consistently checking my Certemy account, and the hours appeared to be logged successfully. Personally, I find operating Certemy counterintuitive, which contributed to this mistake. I am not a technologically savvy person. Even with this, I take full accountability for my lack of diligence. I believed the contract was completed successfully, and seeing each session logged by my supervisor in the record log mistakenly indicated to me that all was in order. I am humbly requesting grace from the board. I am requesting that the 62 hours I have completed outside of the submission period be deemed valid and count toward my clinical licensure.
