



I have accepted a new job offer working as a Social Worker in the adult psych unit at River Oaks Hospital. I feel this will be a positive change in my social work journey as this allows me to gain all levels of experience in terms of properly understanding the mental health diagnosis and mediation aspects involving the work I will be doing.

Through this change moving forward one aspect I wish to not change is Jackie Kellett, LCSW-BACS, LAC (#11616) being my supervisor. I feel like the relationship I have been able to form with Jackie Kellett cannot be replicated with any other supervisor. I hold great value in the insight that she can provide to me through my professional transition. Jackie Kellett is extremely knowledgeable in the Social Work code of ethics, DSM-5 diagnosis, and my personal developmental needs as a clinician. Jackie Kellett has a vast wealth of knowledge in term of working with many populations through her professional career and I feel as though she is able to provide me the proper support and knowledge that I will need in order to grow into the proper clinician I am able to be.

We are requesting the ability to continue virtual supervision for several reasons. Neither Ms. Kellett or I are able to complete supervision during the typical business hours of 8:30am – 5pm due to the nature of our current jobs – supervision must take place in the evenings. Ms. Kellett does not have private office space that would ensure confidentiality for all parties involved, and meeting in a public space presents confidentiality concerns, especially concerning due to federal protections of persons receiving substance use disorder treatment. Ms. Kellett is located in the city of Marrero, which I do not reside in. I am located in a city that is 15 miles away, which is approximately half an hour away with traffic not being factored in. At the time of day in which supervision is expected to be scheduled for having to get through the entire city of New Orleans at 6/6:30pm on a weekday would be well over an hour of travel each way. This creates a hardship and leaves me at a great disadvantage with getting an adequate amount of sleep that night each week in order to fulfill my work duty requirements the next day for my clients' needs. In order to avoid this grave inconvenience, Ms. Kellett utilizes Simple Practice, a virtual platform that is already HIPAA compliant with a BAA to ensure confidentiality of both clients and record keeping. Ms. Kellett is available via the telephone if an emergency or technological failure occurs.

While I understand the importance of in-person supervision and intend to maintain that for individual sessions, conducting group supervision virtually will enable my supervisor to effectively manage her responsibilities across a broader geographic area without compromising the quality of supervision.

The distances from Shreveport, where my supervisor resides, to the residing cities of my coworkers who will be under supervision as well are located as followed:

- Shreveport to Baton Rouge: 250 miles (approximately 4 hours by car)
- Shreveport to Alexandria: 125 miles (approximately 2 hours by car)
- Shreveport to Monroe: 100 miles (approximately 1 hour and 45 minutes by car)

Requiring all supervision sessions to occur in person would result in significant travel time and logistical challenges for my supervisor, given the geographic spread of her supervisees.

Virtual Supervision Platform:

We propose using Microsoft Teams for virtual group supervision. Microsoft Teams complies with Health Insurance Portability and Accountability Act (HIPAA) standards, ensuring the security and confidentiality of supervision sessions through features such as:

- End-to-end encryption for calls and messages
- Secure data transmission and storage
- Role-based access control and permissions
- Multi-factor authentication for all users

Confidentiality and Security Measures:

To protect confidentiality during virtual supervision:

All sessions will be held in private, secure locations by all participants.

- Participants will use personal or work devices secured with strong passwords.
- No session recordings will be made without prior consent from all participants.
- Case discussions will utilize de-identified information to the greatest extent possible.



I hope this letter finds you well. My name is Karely, and I am writing to seek your understanding and assistance regarding my supervision hours as a licensed master social worker. I have completed 54 hours of in-person and online supervision under my supervisor, Mrs. Rebecca Brown, LCSW, BACS #2798 from December of 2022 to May of 2024. Unfortunately, due to a misunderstanding and technical difficulties with the Certemy platform, my supervisor was unable to fill out the required supervision contract, and I was not notified. This oversight was not intentional, and my supervisor is deeply sorry for the inconvenience it has caused. It was only with new supervision by Mr. Andrew Wilson, BACS that I found out about this misunderstanding. He encouraged me to attempt to resolve this matter immediately.

As the only social worker in a Title I school (West Carroll Parish), I am faced with the challenge of continuing to provide necessary support to my students and their families without formally recognizing my supervision hours. I have attached documentation proving that the West Carroll Parish School Board has paid for my supervision that began in December of 2022 and ended in May of 2024 (due to Mrs. Brown's retirement). I am therefore requesting leniency in this matter. It would mean a great deal to me if you could consider accepting the hours I have already due to my parish's financial investment through the ESSER III Incentive (189) grant and the lack of a formal contract in Certemy along with not wanting to not utilize federal money effectively.

I am committed to my role and the well-being of the students I serve, and I believe that resolving this issue promptly will allow me to continue providing essential support without interruption toward further licensure. I do apologize for the immense delay in my request, however, I had requested documentation from the parish and it took longer than anticipated. They were finally able to provide their records and I have attached them as well to this petition. Along with Mrs. Brown having immense trouble navigating Certemy and my countless outreach to her she finally completed it today, January 17, 2025. I have been attempting to reach her since October 2024 and provide her assistance. I appreciate your understanding and consideration of my situation, and I plead for a favorable response.

I am writing this letter in regards to my LCSW Application to elaborate on why it took me longer than 4 years to complete my supervision hours. While waiting for my application to be processed I was informed that my supervision hours did not meet the 4-year requirement. Throughout my supervision I have been employed at a K-12 School as a 9 month employee. During my first two years of supervision (9/2019-03/2020 and 11/2020-5/2021), I worked as a social worker half of the day and the other half of the day I worked as a teacher, which did not allow me to meet my 40 hour a week requirement for weekly supervision meetings. We also experienced school closure due to COVID. In September 2021 I became a full time social worker, allowing me to meet the 40 hour a week requirement for my supervision meeting but only from September - May. The dates for those years are as follows: 9/2021-5/2022, 9/2022-6/2023, and 11/2023-5/2024.

I have a few questions regarding the RSW status. I need clarification on the board's recommendations for services that an RSW is permitted to provide.

I understand that RSWs are not permitted to provide advanced practice and clinical practice. I understand that RSWs are not permitted to commence advanced and clinical practice under the auspices of their own LLC. I also understand that RSW's are not permitted to bill for services.

With that said, please reference the provided board policy and the clarifying questions below.

LABSWE Questions regarding: An individual registered as a registered social worker may engage in generalist social work practice based on the application of social work theory, knowledge, ethics, and utilizing problem-solving methods to restore or enhance social functioning of individuals, families, groups, organizations, and communities through assessment, prevention, and intervention and evaluation, case management, information and referral, supportive counseling, advocacy, research, supervision, community organization, education, and the implementation and administration of policies, programs, and activities. A social worker at this level (RSW) shall work as an employee in an agency and shall not engage in advanced practice or in clinical social work.

- 1. Is an RSW prohibited from commencing <u>non-clinical</u> case management services under the auspices of their own LLC? Please provide a reference for the applicable LABSWE polices.
- 2. Is an RSW prohibited from commencing <u>non-clinical</u> psycho-education services under the auspices of their own LLC? Please provide a reference for the applicable LABSWE polices.
- 3. Is an RSW prohibited from commencing <u>non-clinical</u> behavior activation skills services under the auspices of their own LLC? Please provide a reference for the applicable LABSWE polices.
